50 Victoria Street, Brunswick East**

We refer to our previous discussions and confirm that council's street numbering policy for multi-level developments requires that they designate ground floor Lots/Units with an address pre-fixed with the letter 'G' (eg. G1, G2...etc) and that the floor above is Level 1 with Lot/Unit numbers pre-fixed with the numeral '1' (eg. 101, 102...etc) and so on.

As a consequence, the Lot numbering that we had adopted on earlier versions of the Plan of Subdivision no longer correlated with the council allocated street addresses.

In order to avoid any future confusion, we have amended the numbering on our Plan of Subdivision to match the street addresses proposed by council and below is a listing of the relevant numbering for your records:
